# 111. MINUTES OF THE PREVIOUS MEETING AND MATTERS TO REPORT

## 113. NEIGHBOURHOOD PLAN

Cllr Barker proposed, seconded by Cllr T Martin and on being put to the meeting it was **RESOLVED that** Faversham Town Council supports the creation of a Neighbourhood Plan.

Cllr Barker proposed, seconded by Cllr Perkin and on being put to the meeting it was **RESOLVED** that Faversham Town Council approaches the neighbouring parishes to introduce the development of a Neighbourhood Plan and discuss potential alignment.

Cllr Barker proposed, the motion *"Faversham Town Council elects members of the Council to sit on a Neighbourhood Plan Steering Committee, alongside the community representation through the Faversham Future Forum".* Cllr Saunders proposed an amendment to the motion to change Steering Committee to Steering Group, which was seconded by Cllr B J Martin and agreed by all.

Cllr Barker proposed, seconded by Cllr T Martin and on being put to the meeting it was **RESOLVED** that Faversham Town Council immediately elects members of the Council to sit on a Neighbourhood Plan Steering Group, alongside the community representation through the Faversham Future Forum.

It was proposed by The Mayor, Cllr Reynolds, seconded by Cllr T Martin and on being put to the meeting it was **RESOLVED that the Mayor, Cllr Reynolds, Cllrs Barker, Irwin and Belsom be Faversham Town Council's representatives on the Neighbourhood Plan Steering Group.** 

#### 114. 20's PLENTY

It was proposed by Cllr Thomas, seconded by Cllr Perkin and on being put to the meeting it was **RESOLVED** to co-opt Amanda Russell, Tim Stonor and Chris Oswald-Jones to the 20's Plenty Committee

#### 115. THE MALL

It was proposed by Cllr Thomas, seconded by Cllr B J Martin and on being put to the meeting it was **RESOLVED that Faversham Town Council** writes to Michael Payne, the new KCC Cabinet member for Highways, in support of The Mall residents group's campaign for a pedestrian crossing on The Mall/Forbes Road

#### 116. CLIMATE AND BIODIVERSITY

It was proposed by Cllr Saunders, seconded by Cllr Thomas and on being put to the meeting it was **RESOLVED** that Faversham Town Council write to Swale Borough Council to suggest a Swale Cycles Scheme, utilising money from the Special Projects fund. Cllr Hook asked for the last paragraph of the minutes to be removed which related to a Green Party event, due to the promotion of a political party event during purdah. The Town Clerk disagreed, as the meeting took place before purdah and the minutes were a true record, but would seek guidance from KALC.

#### 117. POLICY & FINANCE COMMITTEE

It was proposed by Cllr B J Martin, seconded by Cllr Barker and on being put to the meeting it was **RESOLVED** to accept the Minutes of the **Policy and Finance Committee dated 29th October 2019** 

#### 118. 2018-2019 AUDIT

The Town Clerk confirmed that audit had been undertaken and no issues had arisen. She noted that an additional fee of £430 had been charged, following a query to the Auditors, PKF Littlejohn, by a member of the public.

#### 119. FAVERSHAM HOP FESTIVAL

It was proposed by the Mayor, Cllr Reynolds, seconded by Cllr Perkin and on being put to the meeting it was **RESOLVED to allow the Faversham Hop Festival to use the strapline 'Supported by Faversham Town Council'**.

#### 120. COOKING UP IDEAS

The request for funding was noted, however the grant money for this financial year had already been distributed and it was agreed to invite Brogdale CIC to apply next year. It was also suggested that they contact the Deputy Swale Member of Health and Wellbeing and contact other groups such as the community chef rather than replicating what is already available.

#### 121. DBS/FIRST AID

It was proposed by Cllr Knights, seconded by Cllr Hook and on being put to the meeting it was **RESOLVED to undertake DBS checks**, which were for the organisation rather than an activity, but to defer first aid training

#### 122. CHRISTMAS DISPLAY

It was proposed by Cllr Knight, seconded by Cllr Jackson and on being put to the meeting it was **RESOLVED** that 12 Market Place could be used as a drop off for presents for Needy Children at Christmas in Faversham and Canterbury, as a 'reverse Santa'

#### 123. NEWSLETTER

It was proposed by Cllr Knights, seconded by Cllr Hook and on being put to the meeting it was **RESOLVED** that the newsletter remain the same colour throughout the year and be mint green, the same colour as The Guildhall

#### ANNEX

Mr Taylor asked if there was any feedback from Southern Water regarding the foul sewage at Lady Dane. The planning permission had expired and the developers were having to go back to Swale.

Mr Goodwin suggested the Town Council write to Southern Water and the Environment Agency. Cllr Perkin is in discussion with Southern Water and trying to set up a meeting.

Mr Oswald-Jones asked if Cllr B J Martin could confirm the legal position on the development at Love Lane. Crest Nicholson's planning permission had lapsed and legal advice was being sought to resolve the situation.
