208. Minutes of the Previous Meeting

It was proposed by the Mayor and on being put to the meeting it was **RESOLVED** to approve the Minutes of the Meeting dated 14th April 2020.

209. Minutes of the Policy and Finance Committee 15th April 2020

The recommendations of the Committee under Minute Ref 105 Committee Structure Review were proposed by Cllr B J Martin, seconded by Cllr T Martin and on being put to the meeting it was **RESOLVED** to accept the amendments committees and the 2020-21 calendar

Cllr B J Martin proposed, seconded by Cllr Barker and on being put to the meeting it was *RESOLVED to accept the Recovery Plan note from the Town Marketing Group*

It was proposed by Cllr B J Martin, seconded by Cllr Barker and on being put to the meeting it was **RESOLVED** that an email from Swale Citizens Advice outlining their proposed use of the funds would be sufficient for the £6,000 grant to be released

It was proposed by Cllr B J Martin, seconded by Cllr Reynolds and on being put to the meeting it was **RESOLVED** that the **Annual Meeting of Faversham**

Town Council is held on 11th May

210. **Emergency Grant Applications**

Cllr Saunders reiterated that the emergency grant had been set up on the basis of providing emergency support for local people. Money had been granted to WFCC for free food parcels, the Town Council, Age UK and the Mutual Aid volunteers etc were quite effective and there has not been a crisis of no food. He acknowledged that we were seeing applications from other organisations because of the period of time, they were now drifting into financial difficulties.

Cllr Perkin noted that Faversham Umbrella may be entitled to funding from SBC. Cllr T Martin reported that one of the applicants was not within the Faversham Wards.

It was agreed to defer the decision on the grant applications.

Cllr Saunders proposed, seconded by Cllr B J Martin and on being put to the meeting it was *RESOLVED that the Policy and Finance Committee review the COVID Emergency Grants Policy and in particular (a) the criteria for giving emergency grants, (b) the possibility of introducing a separate grant to help local organisations recover from the economic impacts of the emergency.*

211. Coronavirus Emergency Update

Cllr B J Martin reported a cashflow shortage for SBC, which was still having to pay out precepts. Bulk waste collections were to resume and household bins were being collected. 327 households were in temporary accommodation. The community response at WFCC had been good.

Cllr Thomas reported that he received daily updates on waste and BIFFA expected to take on extra staff. Parking had been an issue in Tanner Street and the parking team would be doing a letter drop.

Cllr Hook reported on KCC's mental health campaign. The waste sites remained closed.

Cllr Saunders reported that the Faversham Foodbank had cut back on volunteers, but the volume of donations were holding up. The usage was at usual levels and they had been liaising with WFCC.

Cllr B J Martin noted the crowdfunding that SBC were doing to raise money for the voluntary organisations. The issue of whether the duck feeding area at Stonebridge should be open was reviewed, as a number of complaints had been received about crowding issues. Members agreed it should be opened in the hope that people would make the right decision over social distancing.

The Town Council had received a request to become an e-referral agency for the Foodbank. Cllr T Martin proposed, seconded by Cllr Hook and on being put to the meeting it was **RESOLVED** to accept the offer to become an e-referral agency

214. Ramadam

Cllr B J Martin proposed, seconded by Cllr Jackson and on being put to the meeting it was *RESOLVED that Faversham Town Council notes the changes made to religious celebrations by all faith groups during this unprecedented time.*

PUBLIC QUESTIONS

Mr Macdonald

At your meeting held on 14 April Councillor Denise Knights brought up the subject of flying a flag for the NHS on the Guildhall. I was surprised to hear this topic being debated as (under the government guidelines) this is not a flag allowed without permission from Swale planning. I was even more surprised at the council's agreement to fly two flags from the same flagpole! This guidance can easily be found on the internet https://www.gov.uk/government/publications/flying-flags-a-plain-english-guide. My questions are 1) why was this debated and resolved? And 2) why has this not been recorded in the minutes, which only mention the agreement to purchase a NHS flag? I also see that the minutes of the full toon council meeting held on 9 March – which were approved at the meeting of 14 April – have still not been made available to the public. Please let me know how I can get a copy.

Cllr T Martin referred Mr Macdonald to the Town Council's Flag Policy, which allow the Town Council to fly any flag of its choice.

Cllr Irwin agreed it was not a sensible decision and it would be better to fly a NHS flag on a Thursday rather than two flags at the same time.

Cllr Hook didn't think the previous discussion left him to expect two flags would be flown at the same time, it would look odd.
