- b) Use Zoom as the default platform for all meetings, as this is the easiest platform for members of the public to speak live. However, have Teams as a fallback platform should Zoom be unsuitable for a particular meeting.
- c) When using Zoom, permit both live and emailed public questions at full council. Also at their discretion permit committee chairs to accept public questions during virtual Zoom meetings.

#### Background:

With it now being highly likely that we will need to continue with virtual meetings, I believe that we should ensure that are our meetings are more easily accessible.

Currently our meetings are recorded but have not yet been made freely available to the public. The Town Council has recently set up its own You Tube channel so with the agreement of this Council recordings of meetings can now be shared on this platform. NB I've received confirmation that SBC officers may access Zoom via a Web Browser. However KCC officers are not currently permitted to download Zoom onto their lap tops and I am as yet unaware if they are permitted to use Zoom via a Web Browser.
