RE: Notice of Road Closure – Brogdale Road 23rd – 27th March 2020 on behalf of Perry Court Farm (Barratt David Wilson Homes) & Orchard Green (Matthew Homes) Developments, Faversham, ME13 8YA

Further to our courtesy letter dated 20th December 2019, I am writing to advise you that a section of Brogdale Road will be subject to a road closure for the purpose of road re-surfacing, following the completion of the widening of the existing junction connecting to the A2 (London Road) and the associated footpath upgrades. The road will be closed from 23rd – 27th March 2020 from 09:30 – 17:00 every day.

Our appointed contractor Walker Construction Ltd will be undertaking these works, and together with Kent County Council Highways and Streetworks departments; we have agreed to re-surface additional areas that have been subject to wear and tear further down the rural lane.

Please be advised that two way traffic lights will be implemented on the A2 (London Road) to accommodate a safe working area for the re-surfacing and white lining of the carriageway for the first three days of the closure.

Pedestrian access will be maintained at all times during the aforementioned highway improvements; however, due to the nature of the construction works we are unable to provide vehicular access during the closure. In the interest of health and safety, all restrictions will need to remain in force during the aforementioned construction working hours.

Please find appended to this letter the agreed closure extents for Brogdale Road, together with the suggested vehicular diversion routes for the duration of the construction working hours. Due to the nature of the works being carried out increased traffic is foreseeable during the construction period; therefore, we would recommend that drivers allow extra time for their journey before travelling.
