1. About the project you are planning

1.1. What do you plan to do with the Community Grant funding you are seeking?

The funding is for two things. Firstly, the grant will fund the much needed overhaul/repair and maintenance to the garden and the walkways The garden is in constant use and needs to satisfy health & safety requirements and paths to be wheelchair accessible. Labour costs can be kept low as the Faversham Men's Shed project based in the garden will help with this large task.

A second element of the grant is to enable us to participate in the RHS Hampton Court Palace Garden Festival. Having had two winning entries a few years ago we have been invited to submit an entry for the 2021 show. RHS have included a dedicated community allotment area into next year's show in recognition of the important role that community and edible gardening

have played for many of us throughout this year's awful pandemic and lockdowns; community gardening brings us back to nature, boosts our mental and physical wellbeing and helps relieve loneliness.

We would love to take part again this as it has a great `feelgood` factor about it and to have backing from our local council would be wonderful. Our last visit to Hampton Court involved over 60 in the design, growing and installation.

1.2. How have you identified this need?

We have identified the need for repair and maintenance from our regular H&S walk routes. Our latest set of questionnaires showed it has become increasingly difficult for wheelchair users and parents with pushchairs to get around areas of the garden.

The APCG is well used 7 days a week and in normal times has attracted over 5,000 a year. This high usage and footfall have an impact on the wear and tear and safety to members and visitors.

At our last members meeting, the invitation to Hampton Court was discussed with a 100% of members wishing to participate next year.

A key indicator of the need and value of Abbey Physic Community Garden is the continual increase membership - referrals from the local Mental Health Support Teams, local GPs, Occupational Therapists, and from individuals have risen by 22% over the past 12 months.

- questionnaires and surveys to assess accessibility

1.4. What positive legacy will your project leave for future residents of Faversham?

The APCG is a much-appreciated resource for the wider community of Faversham residents and for an increasing number of people who visit our town for its fascinating history and environment. This wider community draw on our resource in diverse ways. As well as our current members and volunteers (currently around 220), we are visited by former members and some bring relatives and acquaintances. Health professionals interested in the therapeutic benefits of gardening visit with and without clients. Local residents, including many of the students who attend the school adjacent to the garden, benefit from accessing a beautiful outdoor space. Schools bring children to benefit from this informal educational resource. Communities interested in establishing similar programmes come to learn from our experience. In addition, local gardeners and allotmenteers use us as a source of inspiration and advice. We hope that an increasing number of parents will bring their children to play in the revamped mud kitchen.

The Garden offers an inspirational opportunity to establish a tranquil, health giving environment that enables people from all sectors of society to come together. The health and safety improvements to the garden will enable us to welcome all of these groups.

We recognise that not all members and Faversham residents are able to get to Hampton
Court Flower show so we endeavour to replicate our design back at APCG once the show has
ended. These have been popular features of the garden in previous years.

The Abbey Physic Community Garden (APCG) is a half-acre, award winning, therapeutic garden in the heart of Faversham, Kent. Our core purpose is to help people improve their physical and mental health and wellbeing, build skills and confidence, reduce social isolation and connect with their community. We are a member led organisation, with members taking active leadership roles in the garden. Working in partnership with other community groups is hardwired into the way we work. In just four years we have transformed the garden, more than doubling our income, increased staffing and opening hours, undertaken more outreach work and expanding our membership to over 220. Typically we support up to 60 individuals a week, approx. half male/females and 75% with mental health issues and long term unemployed. These numbers are higher without COVID restrictions. We offer support, companionship and a wide range of activities including therapeutic horticulture and horticulture training, craft activities and skills development. Our community kitchen helps people learn about nutrition, budgeting and how to cook and produces healthy meals for members and visitors to share. The Men's Shed project offers wood working and practical make and mend sessions and encourages men to share their feelings and support each other. We also run a Monthly Happy Café. In response to member needs we offer a range of activities, typically run by volunteers. Recent examples include Singing Group, Drumming workshops, floristry, litterpicking and Death Café. Our bee hives and friendly chickens provide further activities for members to get involved. These diverse activities complement each other. For example people who come to garden become interested in cooking the food they have grown. Last year we delivered over 6000 staffed activity sessions and produced over 1800 meals. For many however, the Physic Garden is more than activities – above all it is the peaceful environment we offer and the support they get from peers with similar lived experiences.

As an independently funded charity, we concentrate much of our efforts on funding applications for core staff salaries to run our varied programme of activities.

This past year we have reduced member capacity at any one time and increased staff hours to support our members on a rota system. We have also been closed to the public. In a normal year we would be able to rely on income from over 5,000 visitors, so have seen a loss of approx. £10,000 income from refreshments and Faversham Community open days.

We have secured funding for outside hand washing facilities, PPE, 2 large gazebos, tablets to keep members connected and participating and funds towards outdoor heating. We have used our own funds to purchase extra cooking equipment to run our healthy eating outside and Covid safe and purchased materials for additional materials to make other outdoor spaces dry and useable.

Keeping the community garden in good repair and accessible to all is a large job and a very important one.

To have the funding to deliver a project like Hampton Court gives a massive boost to so many members and the wider community, especially after the turbulent year we have all had. A grant towards these costs would be very much appreciated by so many. Thank you for any support you might be able to help us with.
