- 9. <u>Adding paths in Faversham to the Definitive Map</u> To receive the motion that "*Faversham Town Council supports the Faversham Footpath Group (FFG) in claiming any rights of way, not already on the definitive map, under the Countryside and Rights of Way Act 2000.*"

The FFG has been identifying footpaths in Faversham that do not appear on the Definitive Map and believe there are 16 paths that form part of well walked routes in and near the Town.

The Countryside & Rights of Way Act 2000 requires any rights of way not already on the Definitive Map to be 'claimed' by 1st January 2026. If this is not done any such paths could be closed by the landowners and a complicated and expensive process would be needed to reopen them.

To claim the identified paths would require identifying witnesses willing to complete a form confirming they have walked the relevant path for a number of years without any problems, and then submitting a claim for each path. The FFG requests that this process is started with an exhibition in the Town Hall, under the sponsorship of the Town Council.
