#### 359. Minutes of Previous Minutes and Matter Arising

The Minutes were proposed by Cllr Barker, seconded by Cllr Henderson and on being put to the meeting it was *RESOLVED* to accept the Minutes of the Policy and Resources Meeting dated 28<sup>th</sup> March 2022.

#### 360. Ways of Working

Cllr Cavanagh noted that ways of working were applicable for all organisations; in particular it was about giving full attention when others speak, taking part in group discussion; how we treat others on committees and the wider council; commitment to follow up, not stalling actions going forward; not interrupting others while they speak; allowing free flow; sensitivity, integrity; confidential matters kept confidential.

Cllr Henderson raised concerns of individual councillors having informal conversations, as there would be a danger of not everyone knowing. There should be a formality with councillors not giving direct orders to officers.

Cllr Hook agreed there was a need for better relationships with the officers, so they felt they could telephone councillors. He noted there was a staff member against each committee to liaise with. He felt all councillors should be able to input into staff appraisals.

Cllr Cavanagh noted Frome's ways of working and it was agreed to circulate these for discussion at the next meeting.

Cllr Rowlands said he was not able to attend daytime meetings and schedules should work for all
