The Minutes were proposed by Cllr Barker, seconded by Cllr Rowlands and on being put to the meeting it was *RESOLVED* to accept the Minutes of the Policy and Finance Meeting dated 1st June 2021.

256. Month End Report

The Month End Reports were noted and Cllr Barker confirmed he had carried out an audit for April 2021. He noted that our account with Bulb was now £2,000 in debit. The estimated meter reading issues had been resolved, but the reading was very close with only a £300 credit due. We are currently paying £500 a month, where previously with EDF it was £350, the Town Clerk will investigate Octopus as an alternative.

Unpaid invoices were also noted for the moorings, and it was agreed that there should be a process to obtain the payment including using the small claims court if necessary.

The Town Clerk advised that there was a water leak at the Front Brents, which was in hand with Castle Water. She expected this to take some time to resolve based on past experience and noted the high bill received of $\pounds 2,000$.
