On 27 September 2022, we issued a report detailing the results of our limited assurance review of Sections 1 and 2 of this authority's Annual Governance & Accountability Return for the year ended 31 March 2022. We explained that we were unable to certify completion of the review at that time. We are now in a position to certify completion of the review. The external auditor report given in Section 3 of the Annual Governance & Accountability Return requires amendments as follows:

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

1. Section 1, Assertion 2 has been incorrectly completed, the correct response to this assertion should have been 'No' as the smaller authority was not fully compliant with its Financial Regulations in relation to contract tendering procedures.
2. Section 1, Assertion 3 has been incorrectly completed, the correct response to this assertion should have been 'No'. The smaller authority did not advertise contracts in line with Public Contracts Regulations 2015.

Other matters not affecting our opinion which we draw to the attention of the authority:

1. We received challenge correspondence in relation to the 2021/22 AGAR which we considered before completing our work. The authority will receive an invoice in relation to this additional work.
2. It is considered best practice for the Council to have contracts in place with its suppliers. Please ensure the Council is adhering to its Standing Orders and Financial Regulations.
