MAYOR'S REPORT

An Extraordinary Year

This year has probably been one of the most extraordinary in terms of events that the Town has seen. As we emerged from the Covid pandemic and larger gatherings were possible, we saw the return of the many festivals that the town does so well; from the Festival of Transport to the Hat Parade, and the Hop Festival to our Christmas Lights Switch on. I would like to thank those whose work started many months prior to the event, for organising them and putting their heart and soul into ensuring their success. 2022 saw many additions to our regular events, such as the opening of the Faversham Charters and Magna Carta exhibition, the Queen's Platinum Jubilee, those surrounding the Death of Her Majesty Queen Elizabeth II and the proclamation of His Majesty King Charles the third. Before the new civic year on the weekend of the 6th May 2023 we will see the Coronation celebrations. I hope that as when the last King was crowned householders in the town will decorate their premises for Coronation Day.

A war in Ukraine means we welcomed refugees from the conflict, many of whom I have met at the town's events, and I thank all those who have helped them.

Faversham is very lucky to have many groups that contribute in so many and various ways, from those who look after our environment like the Westbrook and Cooksditch streams, to the those who provide support

to individuals from Age UK to the Umbrella Centre, and of course the youth groups, sports clubs and hobby based clubs in the town that make Faversham so special. The Faversham & District Community Lottery has been set up to help those groups and charities in the area.

The Town Council's working groups, committees and sub committees have all reported on their work in this Annual Report, and I would like to thank their members, most of whom are Councillors but not all, along with the Town Council staff for all the work they have put in over the year.

ACTIVE TRAVEL COMMITTEE

Promoting and Facilitating Walking and Cycling

PROMOTING CYCLING

Firstly I'd like to start with the commitment we stated in our annual action plan 2022/23, to "encourage cycling and walking through community engagement and events".

Cyclefest 2022 was a very enjoyable and successful event, and I'd very much like to thank Louise Bareham, Claire Windridge and Adrian Oliver for their support. However particular thanks must also go to Vicky Balfour of "Vicky Bikes" and Caz Conneller of "Cyclechic", who are both enthusiastic promoters of cycling and even convinced me to try a tricycle which I very much enjoyed.

FACILITATING CYCLING

Faversham Town Council won a grant from Swale Borough Council's Eastern Area Committee to start a trial bike hire scheme in Faversham, and to purchase two secure cycle hangers which have been located near the town centre. Both are proving very popular and we continue to review and improve upon the trials. Enquiries can be made via the Visitor Information Centre or directly to the Town Clerk.

BIDDING FOR FUNDING

Much work this last year has been around preparing a potential funding bid to Active Travel England's funding pot to increase walking and cycling, with our focus being on creating a safer environment in Faversham for walking and cycling. We have been supported in this task with the excellent skills and knowledge of

Faversham Town Council's Active Travel consultant Adrian Berendt (20s Plenty coordinator for south east England), and Adrian Oliver SBC's Active Travel coordinator and KCC's Active Travel team.

Faversham originally won funding to implement the 20mph limit, but so far has yet to be successful in gaining further funding from ATE to build a better and safer 20mph area for pedestrians cyclists and drivers. Further this Committee would like to fund and initiate small highways projects itself, however the highways authority KCC has not yet been in a position to agree any projects due to KCC resourcing issues.

As a Town Council our bid has to be agreed by Swale Borough Council and then sent onto Kent County Council for them to collate into their county bid for submission to Active Travel England.

OUTLINE OF OUR POTENTIAL BID PROPOSAL

Our proposal is to focus on encouraging more walking into Faversham Town Centre from the surrounding residential areas of our town, through safer and more pedestrian friendly walking routes. Specifically through interventions that will have the additional benefit of increasing the self enforcing nature of Faversham's 20mph area, and subsequently also encourage more cycling creating safer streets for cyclists.



Some examples:

- Creating a cross town walking route from Bysing Wood road in the west, via Cross Lane, Gatefield Lane and the Long Bridge to Love Lane in the east.
- Lower Road, create a safer walking route into the town centre with raised pedestrian crossings at junctions, plus consider commissioning a design for a new cycle route from the two new estates of Ospringe Gardens and Davington Lakes, along Sumpter Way and along Lower Road towards the town centre.
- Bysing Wood Road, create a safer walking route towards the town centre with newly designed junctions with raised pedestrian crossings and a sensibly designed and located cycle path whilst assisting with further traffic calming and natural self enforcement of the 20mph limit on Bysing Wood Road.
- North Preston and the Brents, create a safer pedestrian walking route into the town centre. This would include a new pedestrian crossing point across North Lane, leading up Partridge Lane to Court Street.
- Improve safety for pedestrians and cyclists along Oare Road by the addition of "speed cushions" and additional 20mph roundels. Plus upgrade the traffic lights at the Oare Road – Lakeside Avenue junction to include traffic light pedestrian crossings. This would link with the new housing development footpath and make walking between Faversham and Oare much safer and more appealing.

- Brogdale Road, London Road and Upper St Ann's junctions. These existing junctions are not safe for pedestrians nor cyclists. To encourage walking or cycling from both the High School and the new housing estates south of the A2, a newly designed junction is needed which should include traffic light controlled crossings, linking residential areas south of the A2 with schools and the town centre north of the A2.

By the time you read this report I hope that we might know if we've been successful in this latest opportunity to bid for Department for Transport's Active Travel England funding.

A FEW MORE WINS FOR FAVERSHAM

We have been successful in winning funding from Kent County Council for smaller individual projects.

1 In progress: safer junctions and pedestrian crossing points where Dark Hill meets Stonebridge Way, Davington Hill and Curtis Way.

2 Scheduled 2023/24: safer Forbes Road zebra crossing and narrower junction with Athelstan Road.

3 Scheduled 2023/24: introduce a new Ospringe Road pedestrian crossing point near the footpath leading up to The Mount play area.

CONCLUSION

Whilst it is and will be a slow process, the Active Travel committee continues to look for funding opportunities to make walking and cycling safer across Faversham.

EQUALITY, DIVERSITY AND INCLUSION WORKING GROUP

Ecological Faversham

In February Faversham Town Council celebrated LGBT+ History month and in March I was asked to speak at the University of Kent about my experience as a woman in local government and how we can work to make being elected to a local Council more accessible to women. This led to a conversation with the Centenary group to look into practical ways Faversham Town Council can look to encourage more women to stand.

October saw Faversham Town Council's first ever Black history month event including two talks from professor Hakim Adi and Dr Onyeka Nubia as well as local Historian Marika Sherwood. There was also a month long exhibition in the Town Hall. Lots of people came to listen to both talks and to walk round the exhibition. We very much hope that this event is the start of a broader conversation about how Faversham can learn more about it's past and all work to become anti racist.

The committee alongside the disability forum has worked this year to look at various inclusion issues that have been raised with the Council. This has included

investing in T-loop hearing assistance in our buildings, advocating for better disabled toilet access in the Town and for more reliable lift services in Faversham station. Members of the disability forum were also consulted on work to improve accessibility at the Swimming Pools and I was pleased to be able to write in support of their successful bid for funding. I have also actively worked with housing developers to look at improving the accessibility of play spaces in the town for both children with disabilities but also parents and carers.

The Town Hall has been lit in various colours throughout the year to recognise important days like "Samaritans day" and to take part in the "wave of light" that marks infant loss awareness week and to welcome Ukrainian families who have made Faversham their home.

Most recently the Town Council put together its second Holocaust memorial exhibition. A poignant exhibition and a reminder that we should always be doing all that we can to stand against hatred.

The Equality, diversity and inclusion committee is open to anyone who would like be coopted from the public that has a particular interest in equality work and we would love to hear from you. If you would like to give some of your time to improve Faversham for everyone then please get in touch.

COMMUNITY COMMITTEE

Serving Your Community

This year the community committee has taken on more than ever and delivered on all aspects that have been put in front of it. This year the town and community of Faversham has started to fully bounce back from the effects of Covid - we have seen the resurgence of Faversham Carnival, with the council and committee helping to marshal the route.

Later in the year the committee in collaboration with Faversham Christmas lights helped to support the 40th anniversary switch on by organising a street food market and live music to make the the celebration a real party!

The community lottery has continued and now supports a huge 59 local good causes and has raised over £40,000 for them, and will continue to support them in years to come.

But the by far and away the largest piece of work that has been undertaken by the committee this past year is the huge investment in youth. The council has committed to spending £30,000 in partnership with VIBE to provide much needed youth work and youth outreach across the town. Over the short 8 months this has been running the money has so far provided 2 summer activity days, many summer sports and hangout sessions and has subsidised days out to activities such as flip out trampoline park and others.

Over the autumn and winter period hot food sessions and activities were run all for free. More recently VIBE has started a

new youth cafe to offer a safe space with opportunities to complete school work or spend time with friends having a hot drink at a much discounted price compared to some of the main chain cafes in the town where they didn't feel welcome.

All in all it has been an excellent year for the committee and has set work in motion that will continue to benefit the town for years to come.

A Great Place to Live is a Great Place to Visit

The Town Marketing Group exists to support and grow economic activity in Faversham. It works especially with the Town Centre retail premises to stimulate growth and activity in the Town.

A major part of the TMG is arranging and helping others to arrange events which bring people into Faversham from near and far to enjoy themselves and to spend money to help Faversham businesses.

From April 2022, 8 events – big and small were arranged, namely:

- The Easter Hat Parade in April
- St. Georges Day celebrations in April
- The permanent Magna Carta and Charters exhibition in May
- Festival of Transport in May
- Queen Elizabeth's Platinum Jubilee in June
- Summer in Swale exhibition in July
- Howl-O-Ween Dog Parade in October
- Christmas Lights Switch On Evening Street Food Market in November

All of these were successful through support from Faversham Town Council but also with huge involvement from voluntary organisations in the Town and from local businesses.

A series of local maps showing attractive walks in the area was also updated.

In conclusion it is good to report that through the hard work of the Town Council and town wide business leaders the footfall throughout the year has grown, helping to stimulate economic

success for Faversham. We have lost a few local businesses throughout the year but new ones have sprung up and many existing retail outlets are achieving success.

LOTTERY WORKING GROUP

Raising Money for Local Good Causes

It has been another successful year for the Faversham and District Community Lottery, which was launched in April 2021. 58 local good causes are signed up and receiving funding through the Lottery and the over 600 players are on track to raise more than £40,000 this year for their chosen causes. There has also been over £10,000 won by local residents during the year. Launching the Lottery has also helped strengthen the relationship between the Town Council and the local community and voluntary sector. A good example being a well supported Volunteer Fair held at the Alexander Centre in October under the Community Lottery banner.

One of the most positive things about the Lottery is that it offers you the chance to support the particular good cause you feel most strongly about. The 59 organisations involved are really varied, including organisations that support the most vulnerable, provide activities for young people, run community events, campaign for a better environment and



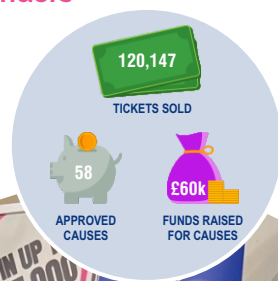

LCWIP WORKING GROUP

Local Cycling & Walking Infrastructure Plan

Faversham's LCWIP was signed off by the Swale Joint Transportation Board in February 2022 and is now adopted by Kent County Council (KCC) and Swale Borough Council (SBC) which means that developers will have to take note of it when they develop new projects. The Plan includes over fifty proposals for making it easier for pedestrians to cross local streets and to slow traffic so bike users can get around more safely.

For the moment the Working Group, which includes community member and officers from KCC and SBC as well as councillors, has continued to meet in order to oversee the completion of two projects – a public consultation on the LCWIP and the Town to Parishes project which is looking at how we can improve active travel links between Faversham and neighbouring villages.

The public consultation on the LCWIP took place during summer 2022. There were almost a 100 responses from the public and feedback also came through a public meeting and a workshop with school students. The consultation responses suggested support for the interventions proposed in the published LCWIP but a need for fresh interventions at Brogdale Road and Quay Lane, which have now been incorporated into a fresh version of the plan.

Good progress has also been made on The Town to Parishes Project, which is funded by SBC. There has been extensive

consultation with local parishes as part of the work and the final report which should be available in May 2023 will include detailed plans for improving active travel links to Boughton, Graveney, Painters Forstal and Teynham, all parishes that have shown an interest in including project ideas in their Highway Improvement Plans. It has also been gratifying to see Sustrans pick up project ideas for the feasibility studies they are doing on improving cycling on the routes to Seasalter and Teynham and that KCC are looking at our route suggestions as they develop a Kent wide LCWIP.

Another local expert, Sue Lamberton, the Silkewoman, provided a session on silk braids.

You can be sure, when you visit, of an interesting talk from any one of our guides.

The guides have now welcomed over 4000 visitors from all over the world. In fact, there is playful competition between them over who can name the furthest visitor!

CREEK WORKING GROUP

Protecting Faversham's Rich Seafaring Heritage

Boats coming into and out of Faversham Creek are part of what makes the town special. The Town Council looks to support that for the benefit of the whole town.

Getting a working Swing Bridge and sluice gates is a priority as this will open up the Creek Basin to more boats and bridge life to that area in the heart of the town. The Town Council's legal advice is that the UK government (specifically the Department for Transport) could issue an Abatement Notice to force Peel Ports to fix it. Kent County Council say their advice says this too. We wrote to the Secretary of State for Transport in August 2021 to demand they do this and hold Peel Ports to their responsibilities. As now (Feb 2022) Transport Ministers say they are still "considering" the matter.

The Town Council believes it is important to keep up the pressure and has launched a petition calling on the government to act. Please sign it here: <https://favershamtowncouncil.gov.uk/community/creek-bridge-campaign/> or see the link via the Council's homepage.

We have expressed our strong disappointment at the government's inaction to our local MP. We are grateful to Lord Monroe Palmer, who lives in Faversham near the Creek, who raising the subject of our bridge in the House of Lords. The Town Jetty which re-opened last year has been increasingly used by boats in Faversham as have the Town Council's moorings on the other side of the Creek. The Town Council is in discussions with

the Faversham Creek Management Company to agree a fair way to use part of the Creek where the Town Council, on behalf of the public, owns the Creek bed but the FCMC own the wall. The installation of new ladders on that section is being discussed to improve safety.

We have also installed new life rings on the Town Jetty and are in the process of installing matting on the bank on the Priory side to enable people who want to take boats or canoes into the Creek to do so more easily, at their own risk, of course. Anyone using the Creek recreational should observe the safety standards and guidelines of relevant associations such as the RYA and BCU.

Last August many people enjoyed watching or rowing in the skiff races organised by Faversham Community Boat Build. Anyone looking to get involved in boat building will be able to find details on social media.

The Creek basin is connected to Stonebridge Pond and the Westbrook stream. Silt in these and the water quality of the Creek are serious environmental issues that will demand attention going forward.

Please do sign the Creek Bridge Petition, calling on the government to get Peel Ports to fix it.

CLIMATE AND BIODIVERSITY COMMITTEE

Ecological Faversham

The Environment Committee has been delivering on the actions needed to tackle the climate and biodiversity emergency. Within the last 12 months the committee has delivered:

- Had a green roof, planted will pollinator rich plants, installed on the Town Hall to help with increasing biodiversity.
- Purchased Thermal Imaging cameras to assess where insulation gaps are in residents' homes – 16 visits have been carried out so far to properties in Faversham under the pilot scheme which was launched in December. This is carried out by volunteers and is a free service. Information and advice is provided at the end.
- We gave away 450 small native trees to be planted across the town in a bid to increase tree cover. In December 2022, residents and community groups were able to pick up a free tree to plant in their gardens.
- Provided funding for community groups and school projects such as a Lovely World event, taking place in June 2023 and ASGAR project, by QE school students, which looks at atmospheric gases to help better understand the effects of climate change.
- Have increased locations for community gardening and uptake in volunteers. There are many locations around the town where volunteers look after beds, planters and gardens to improve the beauty in the town and increase biodiversity. Faversham also was awarded gold in the South and Southeast in Bloom.
- Funded a new bench on Flood Lane and doing work to identify other locations that might need seating.
- Working with Swale Borough Council on works that need to be done to Stonebridge Pond, because of years of silting and neglect.
- Putting pressure on Southern Water and other responsible agencies over pollution in local water sources such as Faversham Creek and chalk streams such as the Westbrook and Cooksditch.
- Allocated funding to improve air quality in Ospringe by planting hedging and trees in Ospringe Street.
- Installed 2 new planters in the town centre with pollinator friendly plants.
- Continuing with work to become a pesticide free town, with successful moves forward in pesticides being removed from contracts at both Kent County and Swale Borough Councils.
