- c) Although the individual ranking system for prioritising interventions remains, its importance is less, with interventions being grouped into a series of projects. It is these projects that have been prioritised. On the attached list, six projects have been given higher priority and are included in Swale Borough Council's bid to KCC for funding as part of Active Travel Fund Tranche 4. These are:
  - Cross Town Walking Route
  - Lower Road junction improvements
  - Bysingwood Road cycleway enhancements
  - North Preston Walking Route
  - Oare Active Travel Route
  - North South Active Travel Route

#### 7. Future of the Group

JS noted that the LCWIP Working Group had been set up by the Town Council to oversee the development of the Faversham LCWIP. Although this is now complete, the group has continued to meet to continue to revise the document and to oversee the completion of the Town to Parishes Project.
