# 121. REMOVAL OF DISABLED PERSONS PARKING BAT

The meeting received the request from Swale Borough Council to remove a Disabled Persons Parking Bay from 62 Whitstable Road. It was proposed by Cllr H Perkin, seconded by Cllr J Rowlands and on being put to the meeting it was **RESPLVED to support the proposal.** 

#### 122. PLANNING ENFORCEMENT STRATEGY

The meeting received the draft Planning Enforcement Strategy from Swale Borough Council.

It was proposed by Cllr T Martin, seconded by Cllr J Saunders and on being put to the meeting it was **RESOLVED to submit the comments**:

- 1) The document is procedures rather than strategy. There are no details on how SBC will engage with Parish Councils or the general public which is fundamental to make enforcement work.
- 2) There is historical evidence of major developments not being built to approved plans. There are no details on how Planning and Building Control will collaborate to ensure build outs are to approved plans or when there are potential breeches.
- 3) Concerns were raised about enforcement outside of office hours and this could be improved.
