THE KENT COUNTY COUNCIL (VARIOUS ROADS, BOROUGH OF SWALE) (WAITING RESTRICTIONS AND STREET PARKING PLACES) (AMENDMENT No.41) ORDER 2023

Notice is given that KENT COUNTY COUNCIL under sections 1(1), 2 (1) to (3), 3 (2), 4 (1) and (2), 32 (1), 35 (1), 44, 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Schedule 9 to the Act, hereby make the following order:-

The effect of the made named Order will be to install waiting restrictions in the following lengths of road (in this part of the notice DYL's means double yellow lines) waiting to be prohibited at any time.

Roads in Faversham, Iwade & Graveney in the Borough of Swale

FERRY ROAD - DYL - (1) On the east side from its junction with Woodpecker Drive for a distance of 4 metres in a northerly direction. (2) On the west side from the northern junction with Sheerstone for a distance of 7 metres in a southerly direction. (3) On the west side from the southern junction with Sheerstone for a distance of 5 meters in a northerly direction. GROVEHURST ROAD - DYL - On the north side from its junction with Kingfisher Close for a distance of 10 meters in a westerly direction. HOMESTALL LANE - DYL - (1) On the east side from its junction with the Brenley Corner roundabout for a distance of 257 metres in a north easterly direction. (2) On the west side form its junction with the Brenley Corner roundabout for a distance of 147 meters in a north easterly direction. KINGFISHER CLOSE - DYL - On both sides from its junction with Grovehurst Road for a distance of 15 metres in a northerly direction. OSPRINGE ROAD - DYL - (1) On the northeast side extend the existing lines by 12 metres outside 136/138 Ospringe Road in a south westerly direction. (2) On the southeast side extend the existing lines by 8 meters opposite 136/138 Ospringe Road in a south westerly direction. SANDERLING WAY - DYL - On the south side from its junction with The Street for a distance of 11 metres in a westerly direction. SHEERSTONE - DYL - (1) On the west side from its northern junction with Ferry Road for a distance of 13 metres in a south westerly direction. (2) On the west side from its southern junction with Ferry Road for a distance of 17 metres in a north westerly direction. (3) On the south side from its northern junction with Ferry Road for a distance of 15 meters in a westerly then southerly direction. (4) On the north side from its southern junction with Ferry Road for a distance of 13 metres in a westerly then northerly direction. THE STREET - DYL -(1) On the west side from its junction with Sanderling Way for a distance of 8 metres in a southerly direction. (2) On the west side from a point 3 meters south of the northern boundary of 40 The Street for a distance of 19 metres in a southerly direction. WOODPECKER DRIVE - DYL - On both sides from its junction with Ferry Road for a distance of 20 metres in an easterly direction.

The Order was made on 27 July 2023 and its provisions will come into effect on 28 July 2023.

The Kent County Council, acting as the Local Traffic Authority and in exercise of its powers and under Sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 44, 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984 ('the Act') and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby propose to make the following Order:-

- A This Order may be cited as "The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Amendment No.41) Order 2023" ('this Order') and shall come into force on the 28th day of July 2023.
- B "The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2019" ('the Order of 2019') shall have effect as though-

FIRST SCHEDULE NO WAITING AT ANY TIME

Roads in Faversham in the Borough of Swale

The following to be inserted to the First Schedule of the Order of 2019 in place of the existing entry:-

OSPRINGE ROAD

- (1) On both sides between points 20 meters east and 212 meters west of the junction with Cambridge Road.
- (2) On the south side
- (a) from its junction with St Annes Road to a point 6 metres east and to a point 5 metres east of the boundary of 9-11 Ospringe Road;
- (b) between points 18 metres south-west and 10 metres north-east of the centre junction with Capel Road:
- (3) On the north westerly side from the south-west kerbline of Lower Road to a point in line with the boundary of 1/2 Ospringe Road.

Roads in Sittingbourne and Milton in the Borough of Swale

The following to be inserted to the First Schedule of the Order of 2019 in place of the existing entry:-

FERRY ROAD. IWADE

(1) On the east side from its junction with Woodpecker Drive for a distance of 4 metres in a northerly direction.

- (a) from a point in line with the southern kerbline of School Lane to a point 9 metres south of the southern boundary of 10 Ferry Road;
- (b) from its northern junction with Sheerstone for a distance of 7 meters in a southerly direction:
- (c) from its southern junction with Sheerstone for a distance of 5 metres in a northerly direction.

The following to be inserted in the First Schedule of the Order of 2019 in correct alphabetical sequence:-

GROVEHURST ROAD, IWADE

On north side from its junction with Kingfisher Close for a distance of 10 metres in a westerly direction.

The following to be inserted in the First Schedule of the Order of 2019 in correct alphabetical sequence:-

HOMESTALL LANE, GRAVENEY

- (1) On the east side from its junction with the Brenley Corner roundabout for a distance of 257 metres in a north easterly direction.
- (2) On the west side from its junction with the Brenley Corner roundabout for a distance of 147 metres in a north easterly direction.

The following to be inserted in the First Schedule of the Order of 2019 in correct alphabetical sequence:-

KINGFISHER CLOSE, IWADE

On both sides from its junction with Grovehurst Road for a distance of 15 metres in a northerly direction.

The following to be inserted in the First Schedule of the Order of 2019 in correct alphabetical sequence:-

SANDERLING WAY, IWADE

On both sides from its junction with The Street for a distance of 11 metres in a westerly direction.

The following to be inserted to the First Schedule of the Order of 2019 in place of the existing entry:-

SHEERSTONE, IWADE

- (1) On the west side
- (a) from a point in line with the boundary of 8/10 Sheerstone for a distance of 30 metres in a southerly direction:
- (b) from its northern junction with Ferry Road for a distance of 13 meters in a south westerly direction:
- (c) from its southern junction with Ferry Road for a distance of 17

metres in a north westerly direction.

- (2) On the north and south side from the western kerbline of Sheerstone for a distance of 25 metres in a westerly.
- (3) On the north side from its southern junction with ferry Road for a distance of 13 metres in a westerly then northerly direction.
- (4) On the south side from its northern junction with ferry Road for a distance of 15 metres in a westerly then southerly direction.

The following to be inserted to the First Schedule of the Order of 2019 in place of the existing entry:-

THE STREET, IWADE

- (1) On the west side
- (a) from the northern kerbline of School Lane in a northerly direction for a distance of 5 metres;
- (b) from its junction with Sandling Way for a distance of 8 metres in a southerly direction;
- (c) from a point 3 metres south of the northern boundary of 40 The Street for a distance of 19 metres in a southerly direction.
- (2) On the east side from a point 5 metres north of the northern kerbline of School Lane in a southerly direction for a distance of 15 meters.

The following to be inserted in the First Schedule of the Order of 2019 in correct alphabetical sequence:-

WOODPECKER DRIVE, IWADE

On both sides from its junction with Ferry Road for a distance of 20 metres in an easterly direction.
