059. Previous Minutes and Matters Arising It was proposed by Cllr Gibson, seconded by Cllr B Martin, and on being put to the meeting it was **RESOLVED to accept the Minutes of the Active Travel Committee dated 28th February 2024.**

It was noted by Cllr Gibson to request an update on the bike storage.

060. Safety of children when travelling to school

A discussion was had on this matter amongst the councillors. Cllr C Martin suggested that this item needs to be put back on the agenda to gain more clarity and more information on Appendix A and who it has come from.

- **061.** Cross Town Walking Route 2 North to South Awaiting to receive sketches on this.
- 062. Highways Improvement Plan It was proposed by Cllr Gibson, seconded by Cllr Jones and on being put to the meeting it was *RESOLVED to agree the following;*

- 1. Signage at suitable locations aimed at preventing high sided vehicles approaching the Ospringe Road railway bridge from the town centre and having to try and navigate back.
- 2. An examination of current and potential parking and traffic calming measures in Stonebridge Way in order to try and improve safety for vehicles and pedestrians.
- 3. Continues concern about the speed of vehicles in the Saxon Road/Briton Road/Roman Road area and requests for additional roundels and repeater signs (this is already identified in the HIP)

Cllrs agreed that item 4 needs looking into further.

4. Concern about vehicles using the narrow part of Cambridge Road, where it comes round to Ospringe Road and whether there would be value in introducing a barrier, making the road one way. This is referenced in the LCWIP and probably needs to be looked at in the context of whole area bounded by Saxon Road/School Road/Cambridge Road/Ospringe Road.

063. LCWIP

An update on LCWIP was received. It was proposed by Cllr Gibson, seconded by Cllr Rowlands and on being put to the meeting it was **RESOLVED to endorse** *the approach.*

It was asked by Cllr Gibson to have a calendar of events to be circulated.

Cllr C Martin gave an update. It was noted that the timetable will need some tweaking, around 10 passengers a day are using the bus (most of those being concessions). Between 3rd April and 23rd April 2024, it was recorded that we had 124 people on the bus.
