Cllr Crayford proposes the motion "Faversham Town Council considers putting documents on public display for the South East Faversham planning application."

### 12. King's Foundation Funding

Cllr Crayford proposes the motion "To protect the council from criticism or unfair challenges regarding integrity, transparency and honesty, the council needs to understand how the Council's actions, however justified and well meaning, could look to the residents of Faversham.

It is likely, that the majority of Faversham residents would perceive that the King's Foundation and the Duchy of Cornwall do have an association however indirectly, via the royal family. With perception, it is irrelevant, if this view is true or not.

To prevent any risk of incorrect public assumptions about the council's attitude to the South East Faversham planning application submitted by the Duchy of Cornwall and the Duchy itself, the Town Council agrees to pause all communication with the King's Foundation until Swale Borough Council have made their decision on the planning application submitted by the Duchy of Cornwall. This will protect the council from public criticism and help to re-enforce our commitment to the Nolan Principles".
