What we plan to do - Active Travel Scheme

Kent County Council are planning to provide a new active travel (walking & wheelchair) route between Lower Road and William Street, Faversham. The proposal also includes new zebra crossings at South Road junction with Lower Road and Newton Road junction with Napleton Road. The works will also upgrade the lighting of the junctions.

The scheme will include: -

- Amendment of parking restrictions on South Road, Bank Street and Newton Road.
- Installation of new bus stop cages markings (operating Monday to Friday between 8am and 5pm).
- New footway buildouts and raised table junctions at Wallers Road, Lion Field, Cressway, Beech Close, Lower Road, Tanner Street, Napleton Road, Bank Street, Newton Road and William Street.
- New zebra pedestrian crossings on South Road/Newton Road and Newton Road/Gatefield Lane.
- New speed cushions on Lower Road.
- New carriageway narrowing at St Marys Road, St Johns Road and Park Road.
- New trees and bench added to enhance the pedestrian environment.

Why are we doing this work?

The government launched a series of funding opportunities for schemes that would increase walking and wheelchair use (active travel). A high priority was placed on schemes that would reallocate road space to encourage active travel.

KCC gathered priorities from Swale Borough Council, the local county councillor(s), and Faversham Town Council to submit a successful bid for funding for a scheme to create improved walking routes to local amenities in the town centre.

The active travel scheme is part of a wider plan to improve general health, support local developments and reduce the reliance of a private car for short trips. Further information on Kent County Council's Active Travel schemes can be found on the link below: -
