Public Questions

It was agreed that increased lobbying of SBC, KCC, and central Government was required on the subject of youth funding cuts.

A presentation was carried out by Laurie McMahon and Gill Wagstaff of Faversham Healthy Futures – slides attached.

100. Apologies for Absence

An apology was received from Cllr Perkin.

101. Declarations of Interest

None.

102. Minutes and Matters Arising

It was proposed by Cllr Rowlands, seconded by Cllr Cook and on being put to the meeting, it was **RESOLVED** to accept the **Minutes** of the Community Committee dated 15th July 2024 subject to an amendment to include Cllrs Golding and Newman as <u>present</u> at the meeting.

103. Community Lottery

The Operator Report was noted.

Cllr Cook queried whether the same picture of a slow decline in ticket sales reflected the wider picture. It was agreed that this would be queried with the lottery operator.

104. Equality, Diversity and Inclusion

The Town Clerk gave an update on ED&I matters.

- An exhibition for Black History Month would be held from the second week of October.
- A calendar of awareness days had been shared for lighting up the Town Hall.

It was agreed that Councillors would consider the appropriate means of marking awareness days to discuss at the next meeting.

105. Discover Faversham / Tourism Strategy

It was noted that footfall counts had been carried out and a report would be ready for the next meeting.

The Town Clerk reported on the Destination Marketing Group. Regular meetings were being held bi-monthly and grant applications had been submitted to Swale BC. Monthly Visit Faversham newsletters were being sent out and an additional 4000 people had signed up to receive them following a campaign in conjunction with South Eastern Railway.

Additionally, Community News had made an approach to see if the Town Council would work with them on a new Town Guide.

Following the success of the Faversham Community Networking Group Z fold leaflet, the idea of creating a Z fold leaflet for local independent businesses was discussed.

The Town Clerk reported on discussions with the company who installed the town centre CCTV system for Swale BC, to see if there was a cost-effective way of installing town centre Wi-fi.

It was proposed by Cllr Rowlands, seconded by Cllr Cook, and on being put to the meeting it was *RESOLVED to move forward with the new Town Guide work with Community News and to contact local businesses to see if they would be interested in a Z Fold Leaflet.*

106. Youth Working Group

It was proposed by Cllr Rowlands, seconded by Cllr Cook and on being put to the meeting, it was **RESOLVED** to open the Youth Grant application period from 17th until 30th September 2024.

107. Events

Councillors expressed their appreciation and thanks to Claire Elliott (Events Officer) for the excellent work she has done on events to date.

The costs of holding the planned events for 2025 were discussed and it was agreed the Committee would need to put the case for increased funding at the Budget Workshop.

An update was provided by the Chair.

109. Christmas Jumper Appeal

It was proposed by Cllr Rowlands, seconded by Cllr Jones, and on being put to the meeting it was **RESOLVED** to agree a Christmas Jumper Donation **Month throughout November**.

It was agreed that Councillors would consider what projects they wanted the Committee to run and make suggestions at the next meeting.

The 2023 Exhibition/Survey...

The questions posed in the survey were:

- O What gets in the way of citizens health?
- What services are important to citizens?
- What would help citizens become healthier?

When the researchers analysed the responses they found that they fell into **four cross-cutting themes:**

- Creating a healthy life...
- Health issues and long term conditions...
- Good local resources and services...
- Preventing ill health...



The Event

- We were invited by the Faversham Society to run one of four 'live talk' events for the town.
- This was held in July and was attended by over 50 local people
- The design involved 6 facilitated discussion groups lasting about an hour preceded with short presentations on the survey results and current health and care issues.

Comments, concerns, issues and advice...

- Improving access, quality and efficiency by decentralising and localising services and...
- Integrating and managing services locally
- Securing the right human and physical resources to do that
- Associated concern that the current local buildings/facilities not being utilised to best effect
- Rebalancing provision of care to include more home/social support/ health promotion/etc.
- Stronger focus on preventing illness rather than just treating it.
- Better (local) mental health and NHS dentistry services urgently required
- More emphasis needed on supporting young people –
- Tackling the immediate problem of obesity especially in school-age children
- Concern that NHS not reassuring public about the impact of any new housing developments on services
- Concern too that L.A. planning process does not emphasise creating healthy environments – open spaces/cycling/walking/air quality/water treatment etc. Does the NHS have any influence?
- Particular concern about how S106 was to be used in planning health and care facilities/services



- work in direct partnership with EK HCP and MK PCN to:
 - ✓ assess future health and care needs then
 - ✓ recruit, train and develop 'Citizen Experts'...
 ...using eminent researchers and practitioners
 - ✓ involve and engage more local people.
 - establish close working relationship with commissioners and providers to...
 - ✓ co-produce a Faversham Health and Care Plan and then..
 - ✓ use it!



some messages about making it happen...

- This is about *involving* the community not just 'engaging' or 'listening' or 'communicating' or 'informing'...
- Localised co-design vital if a community is going to own the inevitable changes to their health and services
- If not owned, then expect 'placardists' and aggressive social media over even minor changes – making implementation much tougher
- Faversham Healthy Futures will help us learn how best to do this.

and also...

- Traditional management thinking not enough too many interests (professional/institutional/civic/political/personal) involved – just devolving responsibilities is not enough.
- Progress will only made through 'active negotiation' between key interests. Committees won't work - you need a process!
- Faversham Healthy Futures will help us learn how best to do this too!
