It was proposed by Cllr P Cook, seconded by Cllr R Newman, and on being put to the meeting, it was **RESOLVED to commission Daniel Martin to undertake an inspection and provide a report on the Old Pump House**.

# 112. GUILDHALL

Members received that quote from Daniel Martin to oversee and administer the external repair of the Guildhall (Paper 2).

It was proposed by Cllr P Cook, seconded by Cllr J Rowlands and on being put to the meeting it was **RECOMMENDED** to commission Daniel Martin to carry out work as detailed.

#### 113. FAVERSHAM CREEK SILTATION

Cllr P Cook reported that an extended survey had been undertaken. On initial comparison it showed the level of mud in the area has increased as suspected.

#### 116. TOWN QUAY AND BUILDINGS

Members received the report from Cllr P Cook on the Old Town Warehouse. (Paper 4).

It was proposed by Cllr B J Martin, seconded by Cllr J Rowlands and on being put to the meeting it was **RESOLVED** to approve the expenditure of £1,000 on Heras Fencing and £2,000 on skip hire.

It was proposed by Cllr B J Martin, seconded by Cllr J Rowlands and on being put to the meeting it was **RECOMMENDED** to approve the remaining expenditure of £20,000 as detailed in Paper 4.

It was proposed by Clir P Cook, seconded by Clir B J Martin and on being put to the meeting it was **RESOLVED** that Delegated Power be given to the Facilities Manager and Deputy Town Clerk in consultation with the Chair of HBCC for the day decision making regarding The Old Town Warehouse, seeking advice from local experts when beneficial to the project.

Members received the report from Cllr P Cook on the Old Pumphouse (Paper 5) and the Structural Inspection of Roof and Gable Walls (Torcal Ltd.).

It was proposed by Cllr J Rowlands, seconded by Cllr T Martin and on being put to the meeting it was **RESOLVED** that the Structural Inspection **Report** (Torcal Ltd.) be shared with a potential sponsor with the

#### intention of the re bedding of the cornerstones as a matter of urgency in advance of other work.

Members received quotes for determining market rents for the two properties (Paper 6).

It was proposed by Cllr J Rowlands, seconded by Cllr T Martin and on being put to the meeting it was **RESOLVED to defer making a decision until** *the September Meeting.*
