## 122. THE OLD PUMPHOUSE

Members received the Condition Report (Paper 1) from Daniel Martin undertaken in July 2025.

It was noted that a Schedule of Works would be needed before any works commenced.

It was proposed by Cllr P Cook, seconded by Cllr R Newman and on being put to the meeting it was **RESOLVED** accept the quote from Bridgers Law (£2350 plus VAT and Disbursements) to draft a commercial lease.

The Town Council would draft the Heads of Terms in advance of the commercial lease as advised by Bridgers Law.

#### 123. OLD GATE ROAD

Members received the correspondence from Swale Borough Council regarding ownership of the Old Gate which remanded inconclusive.

It was proposed by Cllr P Cook, seconded by Cllr R Newman and on being put to the meeting it was **RESOLVED** to report the structure is at risk to **Historic England**.

#### 124. THE GUILDHALL

Daniel Martin has been engaged as project manger for the refurbishment of the Guildhall. He is presently working on scheduling the work. The Chair and Officers have met with a wood specialist to discuss the arcade.

### 125. TOWN QUAY AND THE OLD TOWN WAREHOUSE

Members received the written report from the Chair who also elaborated during the meeting.

Cllr J Rowlands proposed the following motion:

That the Town Council goes out to tender for a structural survey of the Old Town Warehouse, to enable the committee to prepare a schedule of works. The survey should be completed before a Listed Building Consent application is submitted for the removal of the ground floor partitions.

The proposal was not seconded.

**ACTION**: Quote for structural engineer to inspect areas prior to wood repairs to be requested (AB)

#### 126. FAVERSHAM CREEK SILTATION

It was considered that an annual programme of dredging should be in place with other landowners contributing financially. This would need to be negotiated with the Creek Navigation Company.

The present permission for dredging is restricted to jet dredging, it was considered that alternative methods including plough dredging, when the mud removed is put back into the environment should be considered.

Consideration should be given to ensuring that Swale Borough Council and Peel Ports sluice Stonebridge Pond and the creek respectively.

#### 127. CREEK TIDY

Members received the paper on Creek Clean up which was considered a good initiative. Further consideration should be given to the details of the proposal.
