**444. Ham Farm Appeal Reference APP/V2255/W/24/3350524, Ham Road, Faversham**

Hannah Barter reported she had consulted Simon Bell for advice as to whether there was a good legal case if the Town Council agreed to proceed. He had responded that there were 2 grounds to bring forward a Judicial Review.

Following receipt of the grounds, it was agreed the next steps would be:

- 1) The Town Clerk to write to Simon Bell to confirm the Council wish to proceed and receive his legal advice.
- 2) The Town Clerk to be the main Officer contact.
- 3) The Town Clerk to use SurveyMonkey to receive pledges and each person making a pledge to be given a unique reference number and this to be logged on a spreadsheet. If more money was pledged than required, then all would receive a percentage back. Cash donations would not be received by the Council, only by third parties, and they should make it clear that if the donation was not required it may be used to support other projects, such as tree planting.

## **APPENDIX ONE**

### Questions from Members of the Public

A member of the public representing the Save Ham Farm Group commented that they had been fighting the Ham Farm Development for two and a half years and felt dismay at the loss of the recent Enquiry despite the strong Faversham Neighbourhood Plan and the opposition from the Town Council, the Faversham Society and the Save Ham Farm Group.

The local roads were poor and there was a growing flood risk in the area. Although Swale BC had not met its 5-year Housing Plan, this should not be sufficient to overturn the planning decision.

The Save Ham Farm Group hoped the Town Council would seek advice and if there was a strong legal case, the Save Ham Farm Group undertook to assist with fundraising alongside other concerned individuals and organisations. New members to the Group were encouraged to help in this fight.

A member of the public referred to the short time frame the Town Council now had following the decision of the Enquiry and the terms that the Council could seek a statutory review.

A member of the public expressed disappointment at Swale BC stopping work on its Local Plan and the Bearing Fruits plan had expired. The member of public pledged support with fundraising.
