# ROAD TRAFFIC REGULATION ORDER ACT 1984

The KENT COUNTY COUNCIL, acting as the Local Authority and in exercise of its powers under Sections 1, 2, 32, 35, 36, 45, 46, 47, 49, 53, 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, the Traffic Management Act 2004, and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby proposes to make the following order:-

1. This Order shall come into operation on day of 2026 and may be cited as "The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Consolidation) (Amendment No.27) Order 2025" ("this Order")
2. The Interpretation Act 1978 shall apply to this Order as it applies for the interpretation of an Act of Parliament.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, "The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2024" ("the Order of 2024") shall have effect as though:
  - (a) Schedule 2 to the Order of 2024 is amended by the replacement or issue of the following Map Title:

BY123 revision 1 replaced by BY123 revision 2  
BZ123 revision 1 replaced by BZ123 revision 2

NOTICE is hereby given that the Kent County Council proposes to make an Order under Sections 1, 2, 32, 35, 36, 45, 46, 47, 49, 53, 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, the Traffic Management Act 2004, and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act.

The effect of the Order is to extend Zone B of the current Faversham Residents' Parking Scheme to include Kingsnorth Road in Faversham. The proposals will also include the installation of short sections of double yellow lines across some of the existing vehicle access dropped kerbs, and the formalising of the existing disabled persons' parking bay outside 3 Kingsnorth Road.

In Schedule 5 to the Consolidation Order of 2024, the following entry in the Table below shall be added to the Schedule in correct alphabetical sequence:-
