As just discussed, please see below the formal funding being offered for design work or construction on active travel initiatives for Faversham. As discussed, please do let me know by the end of this week if you are happy for me to accept on behalf of Faversham and if you would like to use their framework for the Bysingwood project (see further below in this email).

**Ccapability building :**

- Faversham LCWIP Walking Route 2 – Bysingwood

Funding of £35,000 to deliver a feasibility study with potential to add parts of WR 4 and WR6. SBC to commission.

**Capital works:**

- Briton Road/Forbes Road Construction

Faversham – Bramblehill Road Improvements Construction; Faversham – North Lane Improvements Construction funding approved, but TBC following local consultation and confirmation of amount – KCC led

- Faversham LCWIP Walking Route 5

Funding for Detailed Design work of £50,000 – KCC led

If you would like to utilise the Kent Highways & Transportation Framework consultants, please inform us at your earliest convenience.
